

OPERATIONS CALENDAR CROP YEAR 2016 – 2017

The Board administers Federal Marketing Order No. 981, and this requires handlers to submit reports of receipts from growers, shipments and commitments, reserve disposition (when applicable), almonds used in products, transfers to another handler, dispositions in oil or feed outlets, and other items spelled out in the reporting forms. These forms are provided by the Board and **are to be received at the Board's office from each handler by the following deadlines.** (Additional target dates for other Board operations are also detailed.)
